RELEASE AND WAIVER OF LIABILITY (A form and signature are required for EACH participant):

I am aware that motorcycling is an event which poses potentially serious risk of injuries or death to its participants. I understand that I may be injured or die as a result of my negligence, the negligence of others, or through no fault of myself or anyone else because of the nature of the activity in which I am going to be engaged. I also understand that motorcycles ridden on public and private roads are often difficult to control because of road and weather conditions. With this waiver I accept notice of the risks involved in riding motorcycles on public and private roads. The waiver shall remain valid for the within named events, on the DMV Charity Ride weekend, (date), unless expressly revoked by the participant or parent or guardian of a minor, in writing, with receipt acknowledged by DMV Charity Ride Organization, the operator of the DMV Charity Ride. waiver I expressly assume the risk of injury or death due to negligence by Participants of DMV Charity Ride, its members, directors, staff, and any landowners, their families, employees, or tenants over whose land I ride for my own safety. With the knowledge of the foregoing, and as an inducement for DMV Charity Ride Organization to allow me to ride in the DMV Charity Ride Organization, I hereby agree to waive or release any and all rights that I or my heirs may have to make a claim against DMV Charity Ride Organization, the operator of the or any members of its Board of Directors, staff and participants, or any landowners over whose land I ride, arising from any damages, injury, or death which I might sustain. I further agree to indemnify and hold harmless all of the foregoing from any claims which I might make or which might be made on my behalf by others or which might be made against me by others, arising from riding in the DMV Charity Ride. Furthermore, I agree to indemnify DMV Charity Ride Organization, its Board of Directors, members or staff, or any landowners, their families, employees or tenants, for any injury, death, loss or damage to any personal property which might occur during an event sponsored by DMV Charity Ride Organization or held in its behalf or for its benefit, when such injury, death, loss or damage occurs on the property of a landowner.

By signing this waiver and release, I UNDERSTAND THAT I AM GIVING UP (WAIVING AND RELEASING) ANY RIGHT I MIGHT HAVE TO SUE OR MAKE A CLAIM WHICH I MIGHT HAVE OR WHICH MIGHT SUBSEQUENTLY ARISE OR OCCUR AGAINST DMV CHARITY RIDE ORGANIZATION OR ITS MEMBERS AND PARTICIPANTS, OR ITS BOARD OF DIRECTOS, OR ANY LANDOWNERS, THEIR FAMILIES, STAFF OR TENANT, OVER WHOSE LAND I RIDE, FOR ANY INJURIES I MIGHT SUSTAIN WHILE MOTORCYCLE RIDING OR PARTICIPATING IN A MOTORCYCLE ACTIVITY, and that I AM INDEMNIFYING AND HOLDING HARMLESS, DMV CHARITY RIDE ORGANIZATION, ITS BOARD OF DIRECTORS, MEMBERS AND STAFF, AND/OR ANY LANDOWNERS, THEIR FAMILIES, PARTICIPANTS AND TENANTS, OVER WHOSE LAND I RIDE, FOR INJURING ANYONE ELSE WHILE SO ENGAGED. IT IS MY INTENT TO GIVE UP THOSE RIGHTS AND PROVIDE THE HOLD HARMLESS AGREEMENT, AND I DO SO KNOWINGLY AND VOLUNTARILY.
